New Business:

1. Open Sealed Quotes For 2026 Grass Mowing And Weed Eating Contract-Misty Adams-Utilities Director

- One sealed quote was received for the 2026 Mowing. Mayor Craig opened the quote from Pro-Lawn Deck & Tree Care LLC. The lump sum for mowing was \$16,425 with an hourly rate of \$85.
- Misty Adams reviewed the quote and stated that all was in order. Ms. Adams requested quotes from 5 known mowing firms. She recommended the board accept the bid from Pro-Lawn Deck & Tree Care LLC.
- ❖ Judy Carlisle made the motion to accept the quote for mowing from Pro-Lawn Deck & Tree Care LLC in the amount of \$16,425 and \$85 an hour extra work if necessary.

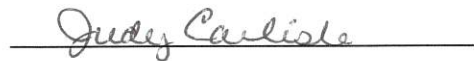
