**1. Request To Accept Awarding Of Bid For 14 Inch Water Main Location And Fire Hydrant Relocation On Southside Of SR 58- 10 Feet Off Pavement 0.1 Miles West Of Fellowship Drive On SR 58-Misty Adams-Utilities Director**

## **2. Request To Accept Awarding Of Quote For Grass Mowing Of City Properties-Misty Adams-Utilities Director**
